Road, Kilkenny.

Mr. Sean McKeown advised that Wexford County Council will be the lead
authority on carrying out development work on Greenways for the three
local authorities - Kilkenny, Waterford and Wexford. A Regional Project
Officer will be based in New Ross. A Section 85 Agreement is required with
Kilkenny County Council. This Section 85 Agreement will allow Wexford

County Council to carry out all surveys, investigations, assessment reports, planning and related statutory consents, design contracts, procurement tendering and construction of works. This Section 85 will supersede the Section 85 already approved by Members some time ago.

Queries were raised by Cllrs. Fidelis Doherty, Melissa O'Neill and David Fitzgerald in relation to the Greenway proposed in Co. Kilkenny, acquisition of lands and the possibility of a potential Greenway from the North of the County to the South.

Mr. Sean McKeown and Ms. Colette Byrne responded to the queries raised.

It was proposed by Cllr. Fidelis Doherty, seconded by Cllr. Melissa O'Neill and agreed that:

"That Kilkenny County Council enters into an agreement under Section 85 of the Local Government Act 2001 to agree that Wexford County Council will act as the Lead Authority for Kilkenny, Waterford & Wexford County Councils to carry out development works on the following Greenways:

- Waterford to Mountelliott Greenway [incorporating The Kilkenny Greenway].
- Waterford to Rosslare Harbour Greenway."

"That Kilkenny County Council would work with potential partners; National Crafts Council of Ireland, Kilkenny LEADER Partnership, the Education and Training Board of Carlow and Kilkenny, The Irish Georgian Society, Kilkenny Civic Trust, The Heritage Council and relevant Government Departments to advance the development of a National Centre for Traditional Building Skills, Decorative Arts and Heritage Led Urban Regeneration in County Kilkenny. Such a centre would become a training ground and centre of excellence for traditional skills and be linked to a possible National Design Centre. This motion recognises Kilkenny's reputation as a centre of design and craft excellence for many decades and the untapped potential in heritage led regeneration of Irish Cities, towns and villages and building traditions."

Cllr. Malcolm Noonan spoke on this motion.

#### 19(18) Cllrs. Tomás Breathnach & Maurice Shortall

It was proposed by Cllr. Tomás Breathnach seconded by Cllr. Pat Dunphy and agreed:

"That Kilkenny County Council write to the Department, Housing & Local Government to seek the extension of grant assistance for all upgrades/replacements of old septic tanks and not only those where upgrades/replacements are required on foot of a septic tank inspection."

#### 20(18) Cllr. Melissa O'Neill

It was proposed by Cllr. Melissa O'Neill seconded by Cllr. Peter Cleere and agreed:

"That Kilkenny County Council recognises that this Council:

- (i) Is deeply concerned of the imminent threat of closure of up to 390 Post Offices throughout the country and the threat to the long-term future of the remaining 690 Post Offices.
- (ii) Believes the decision as to whether a community has a Post Office or not, should not hinge on a Postmaster wishing to retire.
- (iii) Recognises there is an alternative and superior solution to the Post Office issue available to An Post and to Government in the form of the Kiwi (Post) Bank model that was established in New Zealand in 2002, and now has 20% of the banking market and 25% of all banking customers in New Zealand. It has been described as a phenomenal success having made over \$7m profit in its third year of operation and nowadays posts annual profits of circa \$100m.
- (iv) Supports the Dáil Private Members Motion of 11th November, 2016 The Dáil Motion of the 11th November, 2016, passed by the Dáil 158 Votes (no amendments) "Calls on the Government to: implement a new community banking service operated by An Post to be made available in all post offices throughout the country; this post community bank could be based on either the New Zealand Kiwibank model or the German Sparkassen model, both of which have been found to be valid models;"

Therefore, this Council calls on Government to:

- (i) Enact 'Private Members Dáil Motion of the 11th November, 2016.'
- (ii) Postpone the closure of Post Offices while the Kiwi Post Bank model is considered for Ireland."

#### 21(18) Cllr. Breda Gardner

The following Notice of Motion was deferred to October Meeting:

"That Kilkenny County Council fully supports the immediate implementation of 24/7 Cardiac Care in UHW and will encourage fellow Councillors in neighbouring counties of Carlow Tipperary Wexford and Waterford."

#### 22(18) Cllr. Breda Gardner

The following Notice of Motion was deferred to October Meeting:

"That Kilkenny County Council supports the proposal from historian Catherine Corless for a full DNA analysis of the children found in the septic tanks in Tuam and that they be given a proper dignified and Christian burial."

## 12. Notices of Motion from other local authorities seeking support of Kilkenny County Council

It was proposed by Cllr. Pat Fitzpatrick seconded by Cllr. Ger Frisby and agreed that the following Notices of Motion18 (18) to 30 (18) be taken as read and noted:

#### 18 (18) Kerry County Council

"That this Council opposes efforts to require people to work until they are 68"

#### 19 (18) Kerry County Council

"Whilst welcoming the new proposal from An Post to the Post Office Network, I ask that this Council calls on An Post and the Government to seek a new international partner to allow the Post Offices to offer full Banking Services including Current Accounts, Loans and Mortgages."

#### 20 (18) Wexford County Council

"Given the continued efforts of the Department of Local Government to undermine local authorities and the increase centralisation of power in Ireland, this Council calls

on the Government to establish an independent convention on the future of local government, that will examine powers, autonomy and funding. In the event of the failure of government to act, this Council calls on LAMA and the AILG to establish such a convention and to seek cross party support"

#### 21(18) Carlow County Council

"That we, the Members of Carlow County Council call on Carlow County Council to start the process of engagement with Kilkenny County Council to install a pedestrian bridge across the River Barrow at Tinnahinch in south Carlow as the existing bridge has no footpath on either side due to the bridge being so narrow"

#### 22(18) Longford County Council

"That an interim payment of £50,000 be made to the women and families affected by the cervical cancer misdiagnosis."

#### 23(18) Kildare County Council

"That the Council write to the insurance regulator and all home insurance providers who offer policies within County Kildare, voicing our concern, disappointment and opposition to the apparent misinterpretation of the current Catchment Flood Risk Assessment and management Studies [CFRAMS] maps by the insurance industry and the fact that this misinterpretation is now affecting house sales within County Kildare."

24(18) Leitrim County Council

"That Leitrim County Council call on the Department of Education and Skills and/or Department of Health to introduce a scheme to provide all teachers and Special Needs Assistants with Occupational First Aid training, encompassing CPR."

25(18) Donegal County Council

"That Donegal County Council would ask all relevant Government Ministers to reconsider the current government policy regarding the bundling of public contracts."

26(18) Donegal County Council

"That this Council calls on the Minister for Education to address the discrepancies which exist in the rates of pay and benefits paid to ancillary staff in our schools and calls for an end to the precarious employment conditions imposed on these valuable staff members. in addition, this Council calls on the Minister to increase the capitation grant paid to schools as outlined in the 'Action Plan for Education'."

27(18) Limerick City & County Council

"That the Minister for Health, Mr. Simon Harris, TD, and the Minister of State with Special Responsibility for Disabilities, Mr. Finian McGrath, TD, bring forward legislation that all Government Grants, Social Welfare Payments and all other State Supports be categorised as non-means tested Universal Payments for people with Disabilities."

28(18) Limerick City & County Council

That, this Council would call on the Taoiseach and his Government to legislate to ensure that employees who have a recognised degree would be legally entitled to be paid a liveable wage and that their employers would not obstruct these graduates from being in pensionable and unionised jobs and this resolution would be circulated to each Local Authority in the country and to the Local Authority Members' Association [LAMA] and the Association of Irish Local Government [AILG]."

29(18) West Clare Municipal District

"We the West Clare Municipal District Councillors Ian Lynch, Gabriel Keating, Christy Curtin, Richard Nagle, Bill Slattery, Bill Chambers, PJ Kelly and Michael Hillery unanimously agreed at a Special Meeting of the Municipal District Council held on 27th August, 2018 to call on the Government to enact the Dáil motion passed in November 2016 in support of protecting and developing the Post Office network and its services.

In doing so we ask that they:

That concluded the business of the meeting.

- (i) postpone the closures of Post Offices for a 3 year period, to facilitate a restructure of the post office services.
- (ii) ensure that the necessary budget provision is included in Budget 2019 and thereafter to subsidise the Post Office network while it is being developed.

30(18) Waterford City & County Council

"That Waterford City and County Council calls on the Government, in line with a recent motion, unanimously adopted in the Dail, to immediately abolish the 'Loco Parentis' clause in homecare nursing contracts for sick children."
