2. (a) (i) Cuid 8 Molta: Bóthar Bhaile Dhún na nGall Proposed Part 8: Dunningstown Road

Ms. Mary Mulholland gave a PowerPoint Presentation on Proposed Part 8 – Housing Development on the Dunningstown Road, Kilkenny for Members information.

In her Presentation she gave an overview on the following:

- Approved numbers for Housing in Kilkenny City.
- Proposed Public Meeting in January 2023.
- Location of site.
- Plans for six Own Door Apartments.
- Two 2-Bed and four 1-Bed.
- 3D views of proposed development.

She advised that it is intended to proceed to the Statutory Planning process in January 2023.

(ii) Ag Glacadh i gCúram - Taking in Charge

It was proposed by Cllr. Matt Doran, seconded by Cllr. Andrew McGuinness and agreed that:

(b) (i) Polasaí Peataí in Árasáin - Pets in Apartments Policy

Mr. Michael Leahy referred Members to the report circulated with the Agenda. He advised that the use of apartments for social housing is in keeping with national policy on housing densities. Following receipt of a large number of complaints the Housing SPC requested a review of the position in keeping pets in apartments. It was agreed to provide a policy on pets in apartments. A limited number of apartments will be designated where space is provided and where potential disruption to other tenants is minimalised. Priority will be given to support pets where the medical need has been identified. The draft policy has been agreed by the SPC and it is recommended for approval by the Plenary Council.

Contributions were received from Cllrs. Maria Dollard, Fidelis Doherty, Pat Fitzpatrick and Eamon Aylward.

Issues raised by Members were as follows:

- Designation of service animals.
- Breeds of dog not allowed.
- Review operation of Policy in twelve months.

Mr. Leahy advised that an amendment will be made to the Policy following Cllr. Maria Dollards contribution.

It was proposed by Cllr. Eamon Aylward, seconded by Cllr. Eugene McGuinness and agreed that:

"That the "Policy on Pets in Local Authority Social Housing Apartment Accommodation" is hereby approved by the Members of Kilkenny County Council."

Mr. Denis Malone gave a PowerPoint Presentation on Climate Action update.

In his presentation he gave an overview on the following:

- International/National Policy and documents.
- Regional Players Southern Regional Assembly & South East Energy Agency.
- Climate Action Regional Offices role of Regional Officers is to support and advise the Local Authorities.
- Role of Kilkenny County Council prepare Action Plans 6 Strategic Goals to be delivered.
- Overview of progress to-date on Climate Adaption Strategy 2019-2024.
- Next Steps Five Year Plan Action Plan for 2023 to 2028.
- Challenges facing Kilkenny County Council culture change across the organisation and society.
- Goals to be achieved by 2030 & 2050.

Contributions were received from Cllrs. David Fitzgerald, Maria Dollard, Matt Doran, Tomás Breathnach, Pat Dunphy and Pat Fitzpatrick.

Issues raised by Members as follows:

- Iarnród Éireann –electrification of train line from Waterford to Dublin.
- Climate Change must be discussed and reviewed regularly at SPC, Plenary Meetings and MD Meetings.
- Actions set out review, achievements how are they cross referenced to sustainable goals, specific targets on reducing emissions.
- Baseline Studies data available.
- North/South Co-operation.
- Membership of Steering Committee.
- Target date for adoption of Climate Action Plan.

Mr. Malone responded to the issues and queries raised by Members. He advised that all decisions being made will be benchmarked against Council's Plans and Policies and the sustainable goals. All Departments in the Council will be contributing to the targets in the Action Plan as Climate Change affects all services.

He advised that the Minister has until 6th March, 2023 to trigger the process for the Statutory Plan. The Plan will be subject to public consultation and will be adopted by the Members before March 2024.

Mr. Sean McKeown advised that the Climate Action Plan will set out targets for reduction in carbon emissions. He stated that Kilkenny County Council has less than 2% of total emissions for the County. There is baseline data on current emissions.

Cllr. Fitzpatrick thanked Mr. Malone for the Presentation.

(d) (i) Nuashonrú Géarchéime na hÚcráine - Ukrainian Crisis Update

Ms. Fiona Deegan gave a PowerPoint Presentation on "Offer a Home" Programme.

In her presentation she gave an overview on the following:

- Programme to be managed by Local Authority.
- Offer of houses, apartments or holiday homes stand alone units.
- Tax free payment of €800 per month to owner.
- Minimum period of six months.
- 21 offers received to-date.
- Process for applying and acceptance was outlined. Timelines are in place for each of the steps in the process.
- Standards required for properties offered.
- Formal agreement will be a licence.
- Responsibility of utility bills.
- Garda vetting not required as stand alone accommodation only required.
- Details available on website and separate e-mail address to make contact with Kilkenny County Council.

Contributions were received from Cllrs. Pat Fitzpatrick, Andrew McGuinness, Matt Doran, Eugene McGuinness, David Fitzgerald and Deirdre Cullen.

Issues raised by Members are as follows:

- Co-operation of all agencies HSE, ETB and KLP, Community support welcomed.
- Benefits for Communities in Housing displaced Ukrainians in the area.
- Derelict houses challenge to make them liveable services available.
- Unknown number of refugees coming to Kilkenny how are all the services stress tested.
- Knock on affect for Housing Applicants in Kilkenny.
- Rough sleepers in the City.
- Acknowledged contribution of all schools Department of Education for additional resources and integration of the Ukrainians into school life.

Ms. Deegan responded to the issues raised and advised that the properties being offered are not in the market for acquisition or leasing by the Local Authority. Properties must comply with all Housing Standards and Regulations.

She acknowledged all the interagency work especially those in the education area. Ms. Mulholland updated Members on the various funding schemes available for vacant houses:

- Repair and Leasing Scheme.
- Buy and Renew Scheme.
- Vacant Housing Refurbishment Grant.

Kilkenny County Council is promoting all these schemes but there is very little take up.

Ms. Mulholland advised that all rough sleepers have been offered accommodation. Homeless Action Team (*Interagency Group*) meet every Monday to discuss clients that are homeless. Outreach service is in place and they check in daily to assess the needs of the homeless clients.

Ms. Mary Mulholland gave a PowerPoint Presentation on the Creative Ireland Programme. In her presentation she gave an overview on the following:

- New Strategy for period 2023-2027.
- Actions areas and Priority Objectives for the new Strategy.
- Contents of the new Strategy.
- High level priorities for Local Authorities.
- Review of 2017-2022 Programme €½m invested in Kilkenny.
- Projects Highlights of the 2017-2022 Programme that received national recognition.
- Potential areas of improvement for next programme.
- Process for preparation of new Strategy will involve SPC Members and Plenary Council will approve the Strategy.

Cllr. Breathnach raised a query in relation to targets for Housing for All delivery. Ms. Mulholland advised that the overall delivery for 2022 is 183. The target for delivery in 2023 is 149. 136 units are in the pipeline and properties will be purchased to meet the 2023 target.

Cllr. Pat Fitzpatrick stated that the report will be taken as read and any questions can be taken up with the Acting chief Executive.

Mr. Tim Butler advised that the CPG have approved a delegation to travel to New York for St. Patrick's Day in March 2023. The Cathaoirleach, previous Cathaoirleach and one Official will travel. Approval of the full Council is required.
